- The CO, Extinguisher is self-pressurized. The Stored Pressure fire extinguisher has been designed to function i.e. discharge its contents on activation, based on the pressure CO, inside the cylinder. The indicator is the indication of if the cylinder has been operated or not. As long as the gauges needle is in the green zone, the extinguisher will function. In case of a used cylinder, the needle in the gauge will shift from green zone to the red zone. In the event of this occurring, the extinguisher will not discharge properly or at all. It is therefore advisable for customer to periodically observe the gauge to be aware of the state of readiness of the extinguisher and weigh the cylinder as per mandatory guidelines of IS 2190
- The Fire Extinguisher has to be serviced periodically to stay in proper working order. The same is to be maintained as per schedule mentioned in IS 2190 for CO, extinguishers.
- The CO, Fire Extinguisher is warrantied for the period of 10 Year from the date of delivery, as entered in this warranty card, T&C apply. This warranty is against any manufacturing defect.
 - I. CO, Fire Extinguisher must be Hydraulic Pressure Tested from Manufacturer or its authorized representatives after the expiry of Five (5) Year as per BIS Standard IS 2190 and therefore the unit must got hydraulic pressure tested from the manufacturer or its authorized representative.
 - II. In the event of Manufacturing Defect, to be certified by the Company's Engineer, the sole liability of the company shall be either to repair or replace the defective parts or components. However, the company at its sole discretion may decide to replace the fire extinguisher itself. Decision of the company shall be final and binding on the customer.
 - III. The warranty excludes damage caused by mishandling or re-siting by the customer on his own from the original site of its installation or the equipment being opened or modified by any one not authorized by the Company
 - IV. That the Safety Seal is Intact and the Fire Extinguisher has not been tampered with.
 - V. That the Fire Extinguisher must be serviced by the Company's technician or a Technician authorized by Company as per BIS Standards IS 2190.
 - VI. That the QR Code/Serial No. on the Fire Extinguisher is not Damaged.
 - VII. That the Warranty is Valid only on Production of Company's / Authorised Dealer's Purchase Invoice.
 - VIII. This warranty does not extend to any Extinguisher which may have been tempered with, altered or serviced by any agency not authorized by the company and not used as per the specified direction to us.
 - IX. The Company should not be responsible for delay in servicing the Extinguisher due to non-availability or any component or reasons beyond the control of the Company.
 - X. That the company shall under NO CIRCUMSTANCES be liable for any loss or damage caused to the purchaser and/or his/her/its property subsequent to the fire extinguisher not working satisfactorily.
 - XI. That the warranty is governed strictly as per terms and condition mentioned in this warranty card any deviation/ non adherence to the terms and condition mentioned from point I to X shall make this Warranty Null and Void and cannot be challenged or protested under any circumstances.
 - XII. Any Claim or dispute arising out of this warranty shall be subject to the Jurisdiction of Dehradun Court of Law.
